

School Readiness is a public school early childhood program that provides early childhood educational opportunities for children who are at least 3 years old and not yet in kindergarten.

The following information is needed when requesting a School Readiness Scholarship:

- 1. Hand in Hand Preschool Registration and Enrollment options forms
- 2. This application for School Readiness scholarship
- 3. A copy of 2 of the most recent paycheck stubs of ALL contributing members of the household –or-other proof of income (i.e. most recent tax return)
- 4. Follow-up interview
