Dear Students & Parents:

This class is for students fifteen years old or older by the end of the session, and is intended primarily for Northfield Public School District students and residents. Students who are not students of or residents within the Northfield Public School District will be permitted to take the class if it has not filled by the registration deadline. Classes are offered during the year in the fall, winter, spring, early summer and late summer. Complete the registration form below and return it to the Community Services office, along with payment. Registrations are accepted in person, by fax or by mail. Registration is not final until payment is made. *These classes can fill fast, often before the registration deadline. Register as soon as possible to avoid disappointment.*

Fees: ***\$162.00 upon registration for the Classroom Phase*****\$242.00 upon registration for Behind-the-Wheel training**

*These rates are subject to change.

After successful completion of the classroom training, students will receive a Blue Card (Certificate of Enrollment and Classroom Completion) which they will need to take to any Minnesota Driver's license exam station to take their Permit (Knowledge) Test. Cost for replacement of lost or damaged Blue Cards is \$10.00. In addition to the Blue Card, you will need one form of identification from the primary list and one form from the secondary list, detailed in Chapter One of the Driver's Manual. You may take your permit test at any Minnesota Driver's license exam station. The closest stations are in Faribault and Eagan.

You may register for Behind-the-Wheel after receiving your permit. Registration forms will be handed out during the Classroom Phase of Driver Education and are also available at the Community Services office.
