School Board Meeting September 13, 2004 Northfield High School Media Center

I. Call to Order.

Chairperson Noel Stratmoen called the meeting of the Board of Education of Independent School District 659 to order at 7:30 p.m. No one was absent.

II. Agenda Changes.

The table file was added.

III. Public Comment.

There was none.

IV. Approval of Minutes.

On a motion by Wolle, seconded by Zakrajsek, minutes of the School Board meeting held on August 23, 2004, were approved.

V. Announcements.

- Craig Johnson was recognized for his work with Carleton College on implementing
 collaborative research projects between college faculty, high school faculty and high school
 students from urban schools and Northfield. He will be traveling with several others to
 Denver in November to make a presentation to the Geological Society of America. The
 presentation is: Environmental Science at Carleton Summer Program: A Partnership in
 Community-Based Research.
- 2. Nelson reported that she has received several positive comments about the new Middle School and the stop sign on the corner of Jefferson Parkway and Division Street. Thank you to the staff and taxpayers of the Northfield School District.

VI. Items for Discussion and Reports.

1. Kids' C.A.F.E.

Community Education Director Hannah Puczko provided a brief overview of this program for elementary children at risk for not succeeding in school. C.A.F.E. stands for Connections, Academics, Fun and Enrichment. The program will provide a collaborative, comprehensive approach that supports academic and personal growth for students. It brings together the resources of FreePops, Targeted Services and community/college volunteer tutors to support students across the district. It is anticipated that the program will involve 30 students each at Sibley and Greenvale Park and 60 students at Bridgewater.

VII. Superintendent's Report.

A. Items for Individual Action

1. Health and Safety Projects - Phase II.

On a motion by Wolle, seconded by Nelson, the Board unanimously approved the Resolution Stating the Intention of the School Board to Issue General Obligation Bonds to Finance Certain Health and Safety Projects; Covenanting and Obligating the District to be Bound By and To Use the Provisions of Minnesota Statutes, Section 126C.55 to Guarantee the Payment of the Principal and Interest on the Bonds. Voting 'yes' were Dahl, Smith, Zakrajsek, Nelson, Boardman, Wolle and Stratmoen. No one voted 'no.'

2. Middle School Construction Change Order.

On a motion Boardman, seconded by Dahl, the Board accepted change order #22 in the amount of \$28,398.35 resulting in a current contract amount of \$27,049,466.50 for the Middle School BP #2 building construction contract with Adolfson and Peterson, Inc. The total of Middle School Bid Packages 1 and 2 is \$28,552,422.

3. Resolution Calling the School Board Election.

On a motion by Nelson, seconded by Dahl, the Board adopted the Resolution Relating to the Election of School Board Members and Calling the School Board Election.

4. <u>Policies 603, 612, 616, 648, 649, 650, 651, 652 - Curriculum Improvement Process and Staff and Community Involvement, Second Reading.</u>

Boardman moved, and Wolle seconded to approve Policies 603, 612, 616, 648, 649, 650, 651 and 652 on second reading. After several suggestions were made to change wording in many of the policies, Boardman withdrew her motion. Then, Boardman moved and Dahl seconded to approve Policy 612 - Title I, Parental Involvement, changing the wording in Section II, #12 to "To the extent possible, ensure information sent home is in the language used in the home." Nelson moved, Zakrajsek seconded to amend the motion to change the word "possible" to "practicable" resulting in the wording in Section II, #12 to be changed to "To the extent practicable, ensure information sent home is in the language used in the home." Motion carried. On a motion by Wolle, seconded by Zakrajasek, Policies 603, 616, 648, 649, 650, 651 and 652 were tabled until the September 27, 2004, School Board meeting. Board members were asked to give their suggestions for modifications to the policies to the Superintendent's office by Friday, September 17, 2004.

B. Items for Consent Grouping.

On a motion by Zakrajsek, seconded by Nelson, the Board approved the following items listed under the Consent Grouping.

1. Perpich Center for the Arts Grant.

A \$5,000 grant from the Perpich Center for the Arts for the Living History Museum project for third graders at Greenvale Park Elementary School was accepted.

2. Agreement for Professional Services.

The proposal with HaynesHitesman to provide assistance with the request for qualifications (RFQ) for various benefit related services was approved.

3. Advisory Council Appointments.

The Board approved the new members of the Community Education and Recreation Advisory Council and the Early Childhood Family Education Advisory Council.
