School Board Meeting September 26, 2005 Northfield High School Media Center

### I. Call to Order.

Vice Chairperson Noel Stratmoen called the meeting of the Board of Education of Independent School District 659 to order at 7:10 p.m. Nelson and Smith were absent.

### V. Announcements.

- The Minnesota Out of School Time Partnership is partnering with the MN Science Museum to co-host a Lights On Afterschool event. Kidventure's has been chosen to be part of this event, which includes a full day of programming on October 20th at the Science Museum of MN.
- The Middle School currently has 444 students registered for fall athletics. This is 20 greater than last year.
- The Fall Musical, "Oliver" cast and crew is in place. Performances of this High School production will be held on Nov 4,5,11,12 @ 7:30 pm and Nov 6 @ 1:00 pm in the high school auditorium. The musical is under the direction of Bob Gregory-Bjorklund.
- Homecoming Week is Oct 3 thru 8 with many home athletic events scheduled. There will also be royalty coronation the evening of Oct 3 and a high school dance on Oct 8. Other events include a men's volleyball tournament, a powder puff football game and special dress up days. Student Council, advised by David Lynch, is coordinating these events.
- Congratulations to Mark Etzell and his spouse, Amy. Mark and Amy were featured in the recent edition of the magazine of the University of St. Thomas for their work as foster parents. Over the last 11 years, Mark and Amy have cared for 72 foster children, ranging in age from 10 months to 19 years old. They also have four biological children, ages 6 to 12.

# 3. <u>Title IV-E Foster Care Candidacy Administrative Agreement.</u>

The Board approved an agreement between Rice County Social Services and the Northfield Public Schools to participate in the eligibility determination process for the Title IV-E foster care candidacy program.

The Board approved the appointment of Edward (T.) McKinley and Sara Forster to a three-year term (9/05-8/08) and Grace Clark to serve as the one-year liaison from the City of Northfield Park Board (9/05-8/06).
