## IV. Approval of Minutes.

On a motion by Cirksena, seconded by Stratmoen, the minutes of the Regular School Board meeting held on August 28, 2006, were approved.

#### V. Announcements.

• Dr. Richardson referred to the Levy Referendum Guide that residents of the Northfield School District should have received. MSBA is reporting that 56 school districts will be going for an operating levy at the General Election to provide the needed funding to educate students. The average dollar amount being requested is \$1055 per pupil unit.

# VI. Superintendent's Report

#### A. Items for Individual Action

1. Resolution Regarding Structurally Balanced School District Budgets.

On a motion by Stratmoen, seconded by Smith, the Board, on a six to zero vote, approved the resolution incorporating financial projections showing that the proposed Agreement with the Northfield Educational Assistants Federation, Local #6030, Education Minnesota, will not cause structural imbalance in the District's budget during the period of the Agreement and for one year following the period of the Agreement. Voting 'yes' was Berthelsen, Cirksena, Hargis, Smith, Stratmoen and Nelson. Hager had not yet arrived.
