School Board Meeting April 23, 2007 Northfield High School Media Center

#### I. Call to Order.

### IV. Approval of Minutes.

On a motion by Hargis, seconded by Cirksena, the minutes of the Regular School Board meeting held on April 9, 2007, were approved.

# VI. Items for Discussion and / or Reports

1. Proposed 2007-08 Dental Budget.

Tom Stringer presented the proposed 2007-08 Self-Insured Dental budget. Our strategy to switch to a self-funded model in 2005-06 has continued to provide the District with reserves that will stabilize costs to both the District and employees. We will recommend not increasing the funding rates for 2007-08.

This proposal to reinstate the Instrument Rental Agreement that was in place for many years in the District, but has not been actively enforced in recent years, was approved. The payment of instrument rental for band and orchestra instruments loaned to secondary students by the School District will provide funds for repair and upkeep of the existing school inventory of instruments as well as provide funds for the replacement of instruments that are no longer serviceable. Scholarships will be available for those who apply and are eligible. Students who are asked to play an additional instrument in addition to one they are privately renting or own will not be required to rent the school instrument.
