Chairperson Kari Nelson called the regular meeting of the Board of Education of Independent School District 659 to order at 7:10 pm following the organizational school board meeting.

IV. Approval of Minutes

On a motion by Cirksena, seconded by Stratmoen, the minutes of the Regular School Board meeting held on December 8, 2008, were unanimously approved. Then, on a motion by Stratmoen, seconded by Quinnell, the minutes of the Special School Board meeting held on December 22, 2008 were unanimously approved.

V. Announcements and Recognitions

- The Band, Choir, and Orchestra programs had great holiday concerts in December. The performers were incredible as they performed to large audiences.
- The Financial Literacy Challenge is an examination sponsored by the U.S. Dept. of Treasury that students across the country took before Thanksgiving break. Northfield High School had 54 students (out of 104 who took the test) achieve in the top 25th percentile in the nation and one student, Karl Mader, was in the top 1 percentile. 75,000 students across the nation took the test and only 400 teachers across the U.S. had a student in the top 1 percent. The 54 NHS students will receive certificates from the Treasury and Karl will receive a special medal along with his certificate.
- Kylie Hanzlik and Robby Allen, NHS seniors, have been nominated for the MSHSL "AAA" award from NHS. This award recognizes student <u>a</u>cademic, <u>a</u>thletic, fine <u>a</u>rt and community excellence. Kylie and Robby will move on to the Region competition.
- The Northfield Area Foundation Grant Committee has awarded Sibley PTO \$1500 to fund playground equipment. Thank you to Sibley parents and the PTO for their hard work on achieving the goal of a new playground for the 2009-10 school year.
- A Certificate of Achievement was awarded to Erin Mayberry by the Minnesota Recreation and Park Association President and Executive Director for successful completion of the 2008 Emerging Recreation Leaders Institute.
- The results of our District's 2008 United Way campaign are in. Our total giving increased 35% from \$9,675.00 in 2007 to \$17,731 this year. The total number of donors is also up 6% over last year.
- Thanks to all who attended the first annual Holiday Skate on December 21st. Over 100 pounds of food and \$170 were collected through food donations, concessions, and an additional generous gift from a skater. All donations will benefit the Northfield Food Shelf and the Northfield Community Action Center. This event was co-sponsored by the City of Northfield, Northfield School District Community Services Recreation program, Northfield Skating School, Northfield Hockey Association, and PJ's Fabric and Crafts.
- Nelson reported that a Fine Arts Booster Club has been started. If community members are interested in learning more, contact the High School office.
- Nelson thanked the custodial crew for their fine work during these winter months of plowing the parking lots, etc.

3. Resolution Authorizing Execution of Agreement.

On a motion by Berthelsen, seconded by Cirksena, the Board unanimously approved the following resolution:

Be it resolved that Northfield Public Schools, ISD 659, will enter into a cooperative agreement with the Office of Justice Programs in the Minnesota Department of Public Safety. The Superintendent of Schools is hereby authorized to execute such agreements and amendments, as are necessary to implement the project on behalf of Northfield Public Schools, ISD 659.

- 1. Grant Applications to MN State High School League (MSHSL) Foundation.
 - The Northfield Public Schools is a member of the Missota Conference. The Missota Conference is requesting a \$3,648 funding grant from the MN State High School League Foundation to support the MSHSL student leadership initiative, a one-day conference focusing on team building, goal setting, diversity awareness, motivation, confidence building, decision-making, communication and leadership.
 - Northfield High School's RALIE program is requesting a \$5000 grant from the MSHSL Foundation to give RALIE the foundation needed to develop a long-term plan for sustainability of the program.

2. Grant Request to the Southern Minnesota Initiative Foundation.

The Community Services Division, Early Childhood Programs, is seeking a \$4500 grant from the Southern Minnesota Initiative Foundation for the Babies and Blankets Home Visiting Program. If received, the grant will be used to increase the number of families served by this program, both by increasing the frequency of visits to individual families, and by expanding services past one year of

age. Also, funds will be used for home visitor training to maximize the effectiveness of the visits and to enable the Outreach Specialist to do home visits in Spanish.
