VII. Superintendent's Report

A. Items for Individual Action

1. Resolution Establishing Ballot Board.

Since the School District's Special Election is the only item on the ballot this November, the School District is responsible for administering all of the election duties. Minnesota Statute 203B.121, Subd. 1 requires the school board of each district with responsibility to accept and reject absentee ballots must, by resolution, establish a ballot board. A list of the people appointed to the Absentee Ballot Board for the November 8, 2011, Special Election is on the reverse side of the Resolution.

On a motion by Iverson, seconded by Maple, the Board unanimously approved the Resolution Establishing Ballot Board. The Absentee Ballot Board consists of the following employees of the Rice County Auditor/Treasurer's Office: Annette Peters, Laurie Braun, Sue Kalow and Donna Morelan. Voting 'yes' was Fossum, Maple, Iverson, Pritchard, Quinnell, Stratmoen and Nelson. No one voted 'no.'

2. <u>Correction to Special Election Sample Ballot.</u>

At the August 8, 2011, Regular School Board meeting, the Board approved the Resolution Relating To Revoking The Existing Referendum Revenue Authorization Of The School District And Approving A New Authorization, Approving A Capital Project Levy Authorization To Replace

An Expiring Authorization, And Calling An Election Thereon. Included in the Resolution packet was a sample of the Special Election Ballot provided by our legal counsel. On the sample ballot provided by Counsel, the school district's existing referendum revenue authorization was incorrectly identified as \$1,260.90.

On a motion by Stratmoen, seconded by Pritchard, the Board unanimously modified the sample special election ballot that was included in the Resolution packet on August 8, 2011, to reflect the correct current revenue authorization of \$1,269.90.
