School Board Minutes January 9, 2012 Northfield High School Media Center

I. Call to Order.

Board Chair Ellen Iverson called the regular meeting of the Northfield Board of Education to order at 7:10 PM. No one was absent.

III. Public Comment

IV. Approval of Minutes

On a motion by Stratmoen, seconded by Pritchard, minutes of the December 12, 2011, Regular School Board meeting were unanimously approved.

V. Announcements and Recognitions

- Northfield High School Junior Elia Read has been elected as the 2013 Minnesota Statewide Youth Governor! He will preside over next year's Youth in Government program. Elia's campaign video was produced by Chen Ye, also a NHS Junior. This year Northfield High School sent 73 students (up from 42 last year and 29 in 2010). There are about 22 awards given in each program area (house, senate, lobbyists, media areas, court of appeals, trial courts, supreme court, etc) and Northfield students received seven of these awards. A special thank you to teachers Mark Thornton, Brian Stevens and Kevin Dahle as well as Erica Staab (Hope Center Executive Director) and Linda Thornton for chaperoning this year.
- Nelson attended the TORCH celebration last week and noted that while Minnesota may lead the
 nation in having the widest achievement gap that is not the case in Northfield largely because of the
 TORCH program. She congratulated the TORCH program leaders and students and said there are
