 Board Chair Ellen Iverson called the Regular meeting of the Northfield Board of Education to order at 7:00 PM. Nelson was absent.
- II. Agenda Changes / Table File The table file was added.

- IV. Approval of Minutes On a motion by Maple, seconded by Quinnell, minutes of the Regular School Board meeting held on May 29, 2012, were unanimously approved.

The main thrust is a youth component --- stressing the importance of the students in the school taking ownership and driving this program.

2. <u>Transformational Technology.</u>

The cost of the iPad lease is projected at \$40,960.31 each year for the next three years.

B. Items for Consent Grouping

On a motion by Stratmoen, seconded by Maple, the Board unanimously approved the following items listed under the Consent Grouping.

- <u>Revised Contract with ARTech Charter School.</u> Based on MDE's review of the previously approved contract, the District was asked to attach several documents from the current Authorizer Application that provided details on specific contract components. The Board approved the revised Contract with the new attachments.
- 2. <u>Restructuring of Leadership for Early Childhood Education</u>. The Board approved the elimination of the lead teacher positions in Early Childhood Family Education and School Readiness effective June 30, 2012, and the establishment of an Early Childhood Coordinator position for 40 hours per week for 50 weeks per year effective July 1, 2012. The Early Childhood Coordinator would be responsible for all ECFE, School Readiness and Early Childhood Screening as well as a focus on outreach and collaboration in order to reduce the achievement gap. The position will be posted on June 12, 2012.
- 3. <u>Family / Student / Co-Curricular Handbooks for 2012-2013.</u> The Board approved the changes to the Elementary School Family Handbook, the Student Handbooks for the High School, Area Learning Center and the Middle School, and the Co-Curricular Activities Handbook for the 2012-2013 school year. These handbooks carry the force of School Board policy.
- 4. <u>Student Citizenship Handbook.</u> Administration did not recommend any changes to the 2012-2013 Student Citizenship Handbook. The distribution method of the Student Citizenship Handbook for 2012-2013 will remain the same as previous years. The youngest elementary student will receive the Handbook, which will include a page that is to be completed by a parent or guardian indicating that they have received and reviewed the Handbook with their elementary student(s). This page is to be returned to the classroom teacher. Each secondary student will receive a Handbook, which will be reviewed with secondary students at the beginning of the school year.
- 5. <u>Authorization to Waive the Ban of Fireworks or Ammunition on School District Property to Permit</u> <u>Fireworks Display on July 4.</u>

The District waived the ban of fireworks on School District property to permit a fireworks display on July 4, 2012. Permission was granted to use the green space between Northfield Middle School and Bridgewater Elementary School for the fireworks display.
