School Board Minutes October 8, 2012 Northfield High School Media Center

I. Call to Order.

Board Chair Ellen Iverson called the Regular meeting of the Northfield Board of Education to order at 7:00 PM. No one was absent.

III. Public Comment

IV. Approval of Minutes

On a motion by Maple, seconded by Fossum, minutes of the Regular School Board meeting held on September 24, 2012, were unanimously approved.

V. Announcements and Recognitions

- The middle school TEAM UP (Teaching English Learners Action Model to Unite Professionals) teachers completed their two year long grant project last year. The NMS team was so successful that the University of Minnesota faculty awarded them a mini-grant to continue their work for one more year. On September 25th, TEAM UP members held a bilingual parent night for any families who needed assistance in setting up e-mail and family access accounts. They also provided an orientation to middle school life and tours of the school. The event was a big success with over 50 individuals from 20 different families participating.
- Northfield High School Art Teacher Christie Clarke has been named Art Teacher of the Year by Art Educators of Minnesota.
- The Connected Kids Mentoring Program will receive the Robert J. Dayton Quality Mentoring Award from the Mentoring Partnership of Minnesota for addressing sustainability challenges to create stability, exemplifying a unique or innovative mentoring model while maintaining a commitment to quality. Thanks to staff, Linda Oto, Cheryl Strike and Laura Berdahl, and the over 100 community mentors and their mentees who make Connected Kids such a successful program.
- Growing Up Healthy has been selected as the Outstanding Organization Award recipient by the Minnesota Community Education Association. Community Services Division has been a partner in Growing Up Healthy since its inception in 2007.
- United States Senator Al Franken visited the TORCH program on October 4th. He had an opportunity to hear from administrators, staff and community supporters about the origins and growth of the program and the profound positive effect it is having on the graduation rates of Latino and other minority students as well as students who are likely to be the first in their family to attend college. Senator Franken then met with TORCH students and heard personal stories of the support and encouragement these students have received from TORCH staff and volunteers and the effect the program has had on their lives and futures.
- The Bridges to Kindergarten Program, which is strongly supported by the Northfield Area United Way, was featured in the Harvard Education Review. Bridges to Kindergarten was one of six programs identified as exemplary models for the nation in creating collaboration and thoughtful transitions into kindergarten.
