**Disciplinary Guiding Principles:** Context of the incident, how others have been disciplined in similar situations, severity of the offense, honesty of the student involved, repeat violations, impact on others.

"Above the Line" behaviors are what we expect from our students.

"Below the Line" behaviors are incidents where students do not behave as expected by the Student Citizenship Handbook.

"Below the Line" behaviors incidents can range in severity and <u>may create a "Bottom Line" situation</u> that prompts a recommendation for expulsion.

"Bottom Line" behaviors are the most egregious incidents that automatically prompt a recommendation for expulsion.

These are serious transgressions that impact the school environment in the most serious ways.
