## **Committee Report**

Northfield Forward met Monday February 15. Four teachers spoke about their experiences as teachers during a pandemic

Julie Wolner and Theresa Wilson from Business Education spoke first. They described how business courses have always been fluid depending on current events, and content and curriculum requirements. This flexibility over the years allows them to adapt to teaching in the pandemic.

#### Their takeaways include:

- It is difficult to build strong relationships and connections with students via zoom.
- it is difficult using zoom to help struggling students.
- The grade goal of C- or better has not been achievable under distance learning.
- Individual or small group presentations are not possible even in hybrid mode. Presenting to the teacher over zoom was done instead. The students were still required to prepare and present in a professional manner.
- The Business Student of the Month award has not been done.
- Outside speakers over zoom are considered just another zoom meeting.
- Students do not like to talk in zoom meetings. This was emphasized a bit.
- Field trips were canceled.
- Content was reduced and there was less opportunity to apply what they learned.
- Keyboarding /word processing was difficult. For students who didn't have regular keyboards at home one was provided along with an adapter to allow its use with an iPad. EduTyping software proved to be an excellent program for at home learning.

DECA also suffered. Membership was down to 22 students instead of the usual 50-70. All meetings and competitions were virtual. No opportunities to interact with other students with the DECA Store or at competitions with students from other schools.

Pat Riley discussed the difficulties teaching Chemistry. While in school students did labs to get hands on experience. Presentations were eliminated. Instruction time while in person was given priority.

#### His takeaways include:

- Record everything. Enables the opportunity to view over or at the student's convenience. Also provides a record for the instructor.
- He and other science teachers looked at the curriculum and the labs to see what they needed to do and why. For example, they determined a lab that was done in middle school did not need to be repeated.
- He and the other teachers determined to teach chemistry without requiring memorization.
- Pivot Interactives Software for labs works well. One concern was whether it could read the text aloud for those with reading difficulties.

The final presentation was by Erik Burton. He works with EL Portage students. His varied background gives him a broad spectrum of resources and ideas to work with.

#### His takeaways:

- Relationships are hard to build.
- Following up and checking in is important. The use of instant communications like texting is valuable.
- Different students have different backgrounds that need to be considered.
- Though some students might have strong conversational English, reading comprehension may not follow.
- Portage has higher reading level expectations.
- Odysseyware is rigorous but customizable.
- Motivation is difficult to find making building relationships so important.
- It is important to reconsider what is done out of habit.
- As is so often stressed, relationships and connections are so important.
