If staff have completed training prior they will be excused for the afternoon, unless Building Child Nutrition Managers will need them to do anything at their kitchens.

You will be required to complete the following number of professional standards annual training hours each year:

Managers 10 hours

Staff (more than 20 hours per week) 6 hours Staff (less than 20 hours per week) 4 hours So that we can accurately track your training for the School Nutrition Professional Standards requirements please complete the Professional Standards 24-25 Training Tracking Form after completing a course.

If you have taken the ServSafe course within the last 6 months please select Key Area-Operations 2000 and enter Key Area code 2600. Time should be 8 hours. If you took the renewal course time should be 4 hours.
