<b>Job Summary:</b> Under the direction of licensed special education instructional and/or related services staff, the Educational Assistant – Personal Care Assistant assists one or more students in accomplishing activities of daily living; instrumental activities of daily living, health related functions; redirection and intervention of behavior; instructional activities; and other tasks as are identified within assigned students' IEPs.
