 The levy referenda election was held November 7, 2017. The Board is asked to adopt the enclosed Resolution Canvassing Returns of Votes of the School District Special Election as presented.

Superintendent's Recommendation: Motion to adopt the Resolution Canvassing Returns of Votes of the School District Special Election held November 7, 2017, on the question of revoking the existing referendum revenue authorization of the school district and replacing that authorization with a new authorization for taxes payable in 2018 thereafter (question 1) of which 4085 voted in favor, and 3831 voted against the same. Said proposition, having received the approval of at least a majority of such votes, is hereby declared to have carried.

Superintendent's Recommendation: Motion to adopt the Resolution Canvassing Returns of Votes of the School District Special Election held November 7, 2017, on the question of authorizing the issuance of school building bonds for a school acquisition and betterment program (question 2) of which 3467 voted in favor, 4436 voted against the same. The passage of School District Question 2 is contingent upon the passage of School District Question 1. Question 1 having carried and Question 2 having not received the approval of at least a majority of such votes, Question 2 is hereby declared to have failed.

2. Dundas Dome Lease Agreement for 2018.

Enclosed is a lease agreement between Northfield Public Schools and Dundas Dome for the time period January 1, 2018 through December 31, 2018. There are no changes to the 2018 lease from the 2017 lease. Rent for the full facility is \$450 per hour, not to exceed 90 hours within the lease term. The Board will be asked to approve this lease at Monday night's meeting.

As specified in the attached Abstract and Return of Votes Cast, at said election a total of 7929 voters of the school district voted on the question of authorizing the issuance of school building bonds for a school acquisition and betterment program (SCHOOL DISTRICT QUESTION 2), of which 3467 voted in favor, 4436 voted against the same, and there were no completely blank or defective ballots related to this question. The passage of School District Question 2 is contingent upon the passage of School District Question 1. Question 1 having carried and Question 2 having not received the approval of at least a majority of such votes, Question 2 is hereby declared to have failed.
- 4. The clerk is hereby directed to certify the results of the election to the county auditors of each county in which the school district is located in whole or in part. The clerk is also directed to report the results of the referendum revenue authorization election to the Commissioner of Education within fifteen (15) days of the date hereof.
