 Prairie Creek Community School and Arcadia Charter School Annual Reports. Simon Tyler, Director of Prairie Creek Community School, and Barb Wornson, Director of Arcadia Charter School, will be doing a joint presentation of the programs being provided in their two charter schools. Director of Finance Val Mertesdorf reviewed the levy and the current year's revised general fund budget. The public was invited to speak following the presentation. Victoria Roller urged the Board to rethink authorizing the final property tax levy because of the tax impact it will have on people who live on fixed incomes.
 - 2. Energy Efficiency Report.

Director of Buildings and Grounds Jim Kulseth shared information about the District's participation in the Xcel Energy Renewable*Connect program and cost savings as a result of installation of LED lighting at Northfield Middle School.

- <u>Recap of the December 4th Work Session.</u> Superintendent summarized what was discussed at the December 4 work session and proposed next steps:
 - It is necessary to engage the community in determining next steps.
 - A Facilities Committee will be established in January to discuss facilities issues, including the Master Facilities Plan.
 - A workgroup would be formed. The workgroup would consist of a cross section of the community. Its task would be to analyze the Master Facilities Plan and chart the course for how the District moves forward.
 - The community would then be invited to review the proposed modifications to the approved building projects.
 - Staff would take the community feedback and prepare a report, including a timeline, that would be presented to the Board, probably in late Spring 2018.

Literacy Curriculum Adoption Board Presentation: Monday, January 8, 2018

The most important function of a school district is to prepare students for their future, and one of the most important aspects of that preparation is to ensure that every student is literate. This is accomplished through a comprehensive literacy curriculum and by providing many opportunities for success. The goal is to have every student able to read, write, and speak at a high level. The elementary schools are in the process of adopting a literacy curriculum to help meet that goal.

This process is directly aligned to our strategic plan that states that we will prepare every student for lifelong success within a world-class learning environment with a commitment to community partnerships and sustainability. It also fulfills our commitment to ongoing and near-term priorities of robust core instruction and equitable opportunities for all career and college paths.

As reported in the World's Best Workforce report, our results on the Minnesota Comprehensive Assessments (MCAs) in the reading assessment, Northfield School District scores on the reading assessment have been flat or declining over the past five years. Our third grade MCA results in reading have not reached the level we would expect or want for our students. The MCA results also mirror what the data tell us in other assessments such as MAP and DIBELS. We have highly educated and experienced teachers. Our students are great! So we need to examine WHAT we teach: the curriculum materials we are using. The curriculum in place is Literacy by Design, adopted in 2007. This was not updated to reflect the standards change in English Language Arts that occurred in 2012.

Therefore, to put the strategic plan into action, respond to the data, and to update curriculum materials, we are moving through the process of adopting a new literacy curriculum.

This work has been helped by the Minnesota Department of Education's (MDE) Multi-Tiered System of Supports (MTSS) grant to examine the fidelity of implementation of Tier 1 (core instruction), Tier 2 (intervention process), and Tier 3 (specialized and individualized instruction). We received one of three statewide grants to participate in this examination. We began our process in 2016-17 when we took a close look at four areas of implementation of core instruction: teams, implementation, resources, and evaluation. As a result, we have a district elementary literacy team and literacy teams at each school building. These teams then began the process of examining the implementation of our resources. The elementary district literacy team met throughout last year to discuss our beliefs and practice about literacy instruction. This culminated in two days this past June when the team examined three curricular options in depth: Benchmark Literacy, Next Gen from Pearson, and Collaborative Classroom. We used a rubric to rate all three curricula in the areas of building knowledge, foundational skills, high quality text, and evidence based discussion and writing. We had presentations by representatives from each company before examining and rating the materials. Collaborative Classroom rose to the top in every area.

To highlight some of the important dates: The materials have been ordered, arrived, and delivered to the classroom teachers. We will spend the next eight months in training and staff development with full implementation for the start of the 2018-19 school year.

As part of our literacy program, we are implementing online, web based literacy curricula this year. We spent the summer reviewing 13 different programs, and decided on three for implementation this past fall of 2017. Imagine Learning is used in grades 1 and 2; Lexia in grades 3 and 4; Reading Plus is used in grades 5 through 7. Lexia and Reading Plus have received high ratings from What Works Clearing House. Imagine Learning is too new to have a review on What Works Clearing House; however, the MS has used their math program for the past two years and has been pleased with the service and the student outcomes. Three products were chosen to avoid student burnout and to allow teachers the flexibility to move students to another program if the one for their grade level is not producing positive results. We have two-year contracts with these companies so we have time to implement the programs with fidelity and determine after review of the data, if we want to continue to use them with Collaborative Classroom.

Collaborative Classroom consists of three components: Being a Reader in grades K-2; Making Meaning in grades K-5; and Being a Writer in Grades K-5. Social emotional components are embedded in the curriculum that will support and supplement our adoption of the Second Step curriculum. There are 12 sets of readers included in the K-2 Being a Reader portion. The first five sets are phonetic readers and sets 6-12 are authentic literature. Each of the three parts of Collaborative Classroom has embedded authentic literature as part of the instruction. RE: Network Administration Expenditure Reassignment

At the time the Board of Education approved the addition of the Behavior Coaches (PALS) positions at all three elementary schools, Administration proposed moving the assistant network administrator's salary and benefits to the capital budget as on offset to the additional general fund cost.

There are two positions funded by the capital budget that total approximately \$206,170. During our annual capital committee meeting there were requests for \$1.2 million dollars and we are projecting available funding of \$400,000. With the voter approved increase to the operating referendum we have additional general fund support to reclassify the network administrator's salary and benefits from the capital fund to the general fund. This would allow the committee an additional \$200,000 to make needed purchases.

I am recommending this reclassification for the 2018-19 budget. We can reassess during our next capital committee meeting if the needs still outweigh the funding available.

Request: We are requesting an addition of .2 to Lisa Kruger Robb's contract until the end of the 2017-18 school year (June 7, 2018).

Alignment to Strategic Plan:
