- 1. Preliminary Pay 23 RMV and NTC values are based on information from Rice County, Dakota County and Goodhue County.
- **2.** Assumes no change in the value of individual parcels of property from 2022 to 2023 taxes. If the value of a parcel increased, the change in taxes will be larger than shown above.
- 3. Taxes payable in 2023 are based on latest estimates of the District's proposed levy, as of the date above.
- For commercial-industrial property, the tax impact estimates above are for property in Rice and Goodhue counties.
 For commercial-industrial property in Dakota county, the tax impact would be less than shown above, due to the impact of the Twin Cities Fiscal Disparities program.
- ** For agricultural property, estimates above are based on the average value per acre of agricultural land and buildings. The estimated tax impact for taxes payable in 2022 includes a 60% reduction on the portion attributable to school debt taxes due to the School Building Bond Agricultural Credit. The credit percentage increases to 70% for taxes payable in 2023. The house, garage, and one acre of land (HGA) would pay taxes at the same rate as residential homestead property. For property owners with greater than \$1.9 million of agricultural homestead land and buildings, a portion of the property will be taxed according to the higher non-homestead rate.

Preliminary timeline for temporary replacement of Noel Stratmoen | Dec. 12, 2022

Executive Summary: Longtime board member Noel Stratmoen has submitted a letter stating that he is temporarily resigning his seat on the Northfield School District Board of Education due to health reasons. He does not think he will be able to complete his board member duties for at least the next 90 days. This document outlines the statute that governs the process for a temporary replacement and a preliminary timeline for appointing a board member to serve in Noel's stead during his recovery.

Background and statute

According to the Minnesota School Boards Association (MSBA), Noel is the longest actively serving school board member in Minnesota. Noel was first elected in 1982. He is a fixture in our community and has altruistically given his personal time for the betterment of Northfield students' education in five different decades. I ask that our community hold him in their hearts as he continues his recovery.

Because he is temporarily resigning for health-related reasons, the governing statute to fill the vacancy is <u>123B.09 Subd.4</u>, which states:

A vacancy caused by a member being unable to serve on such board and attend its meetings for not less than 90 days because of illness or prolonged absence from the district, may, after the board has by resolution declared such vacancy to exist, be filled by the board at any regular or special meeting thereof for the remainder of the unexpired term, or until such ill or absent member is again able to resume duties as a member of such board, whichever date is earliest. When the ill or absent member is able to resume duties as a member of the board, the board must by resolution so determine and declare such person to be again a member of the board, and the member appointed by the board to be no longer a member thereof.

While this document's intended audience is those considering running for election, it provides those interested with an overview of the governance role that school boards play in Minnesota.	
Jan. 9, 2023	Nominations and appointment of a member to hold Noel's seat until he returns. The item will be the final action item on the agenda. The new board member will be seated at that time.	
Jan. 23, 2023	The new board member will participate in their first full meeting.	

When Noel's health improves to the point that he can return to the board, he will submit a letter indicating so. Then, the board will take another resolution to return him to his seat for the remainder of his current term.
