The front page of this form needs to be filled out only once, but must be completed in its entirety prior to children being left in KidVenture's care. The second page of the form must be filled out any time you wish to add a Wednesday

Families using this one hour option **CANNOT drop off prior to 7:50 AM at Bridgewater, 7:50 AM at Sibley, and 7:45 AM at Greenvale Park.** If you will be using KidVentures prior to 7:45/7:50 on Wednesdays, you do not need to fill out this form, but you **MUST** register with KidVentures and have a regular contract on file. If you do not have a regular contract on file and drop off between 7:30-7:45/7:50, you will be charged the Option 2 Half Session rate of \$6.00/Wednesday. If you drop off prior to 7:30 AM, you will be charged the Option 2 Full Session Rate of \$8.00/Wednesday.

KidVentures will provide care for the 1-hour late starts on Wednesdays throughout the school year. When the 1-hour program ends, students will be dismissed to breakfast or supervised playground time. Students may participate in games, craft projects, homework time, outdoor play, and more. You must walk your child in to the school and sign them in to the designated KidVentures meeting area. Please note: If your child(ren) will attend KidVentures on Wednesday mornings before the 1-hour program begins, you **DO NOT** need to fill out this form as Wednesday late start will be **INCLUDED** in your Wednesday price.

**You must submit payment for your child to attend Wednesday Late Starts.**

**Payments are non-refundable and need to be made PRIOR to your child attending. We STRONGLY encourage families to fill this form out ONE time and register for all Wednesdays needed for the school year. If you register for ALL Wednesdays, the price will be discounted to \$100.00 per child.**
