School Board Meeting January 28, 2008 Northfield High School Media Center

I. Call to Order.

Chairperson Kari Nelson called the regular meeting of the Board of Education of Independent School District 659 to order at 7:05 p.m. No one was absent.

II. Agenda Changes.

III. Public Comment.

Kathleen Doran-Norton lives in Bridgewater Township and serves on the Bridgewater Township Board. She requested that the Board seriously consider composting the garbage collected from the school kitchens. She distributed to the Board a newspaper article from the January 20, 2008, Metro Star Tribune regarding how school composting is growing dramatically in the metro area.

1. MN Summit on Youth Development Presentation.

A 10-minute DVD profiling youth development efforts in Northfield was shown to the Board of Education. Senior Tom Pokorney, representing the Mayor's Youth Council, introduced the presentation. This program was shown during the opening plenary session at the MN Summit on Youth Development in December. The Summit was sponsored by the MN Alliance with Youth and the MN Department of Education.

Senior Claire Carlson, also a member of the Mayor's Youth Council, announced to the School Board that Northfield had been named one of the 100 best communities for young people by America's Promise Alliance, a foundation started by General Colin Powell. The competition identifies communities across the country that have made the well-being of young people a top priority. Each member on the Council completed a portion of the application, which took two months to complete. Other Minnesota communities honored included St. Paul, Mankato/North Mankato, St. Louis Park and Landfall.

2. 2007-2008 Revised Budgets.

Revised budgets for 2007-08 were presented in preparation for the February general fund forecast and the 2008-09 budget planning. Both revenue and expenditure budgets are adjusted where needed to better forecast our year-end position and to help budget managers monitor their plans and activities.
