Organizational School Board Meeting January 11, 2010 Northfield High School Media Center

I. Call to Order.

The Organizational meeting of the School Board of Independent School District 659 was called to order at 7:02 PM by ex-officio member Superintendent L. Chris Richardson for the purpose of organizing the Board for the 2010 calendar year.

II. Organization of the Board.

A. Individual Action Items.

1. Election of Officers.
