School Board Minutes October 10, 2011 Northfield High School Media Center

- I. Call to Order. Board Chair Kari Nelson called the regular meeting of the Northfield Board of Education to order at 7 PM. No one was absent.
- II. Agenda Changes / Table File The table file was added.
- III. Public Comment There was none.
- IV. Approval of Minutes After a typographical error was pointed out ("moral" instead of "morale" during the public comment), on a motion by Quinnell, seconded by Maple, the minutes of the September 26, 2011, Regular School Board meeting were unanimously approved as corrected.
- V. Announcements and Recognitions
  - Closed negotiations strategy session will follow the conclusion of tonight's Board meeting.
  - The Northfield Healthy Community Initiative (HCI) announced the results of the Video PSA Contest on the subject of cyberbullying and responsible technology use. The top vote getter was "That Losing Goal," produced by Hanna Bubser and Samantha Roback. The panel of judges, made up of school district administrators, students, HCI board members and members of the Mayor's Task Force on Youth Alcohol & Drug Use, also selected a "Judges' Prize." That award goes to Zachary Anderson for his video, "Words Have Power." The following individuals also received honorable mentions for their technical merit and relevant content: Connor Balfany, CJ Betcher, Kyle Betcher, David Greer, Seth Hansen, and Chen Ye. All of the video finalists will continue to be available on the School District's website as well as the HCI website. They will also be aired on Northfield Television and shared with local parents and students throughout the Northfield schools.
  - Northfield Middle School is one of five TEAM UP (Teaching English Language Learners Action Model to Unite Professionals) schools in the state. A group of middle school teachers has been participating in a 2 year long grant project with the University of Minnesota. This Thursday, October 13th from 5:30 p.m. 8:00 p.m. there will be a TEAM UP Parent Night. All interested parents are invited to come to learn in a bilingual setting (English/Spanish) how to use family access, set up free e-mail accounts and other helpful tools for parenting middle school students.
- VI. Item for Discussion and / or Reports
  - 1. <u>ARTech Annual Report</u>.

ARTech is in its eighth year of operation. The new Director of ARTech, Ryan Krominga, presented ARTech's 2010-2011 Annual Report. This plan fulfills state requirements for annual reporting as well as the District's request that each charter school authorized by the Northfield Public Schools present an annual report to the School Board.

- <u>Community Services Site Improvement Plan.</u> Hannah Puczko, Director of Community Services, presented its continuous site improvement plan.
- VII. Superintendent's Report
  - A. Items for Individual Action
    - <u>Resolution Providing for the Sale of General Obligation School Building Refunding Bonds, Series 2011;</u> <u>And Covenanting and Obligating the District to be Bound By and to Use the Provisions of Minnesota</u> <u>Statutes, Section 126C.55 to Guarantee the Payment of the Principal and Interest on these Bonds.</u> Jeff Seeley, a Financial Advisor with Ehlers, presented the Pre-Sale Report for \$10,635,000 General Obligation School Building Refund Bonds. The District has been monitoring interest rates in the bond

market for refunding opportunities of previous bond issues. A "comparisons" page from the latest estimates of the impact of refunding the 2003A General Obligation Bonds shows total savings in future debt service just over \$1.4 million, with a present value of just over \$1.2 million, or 10.5% of the present value of the refunded debt service.

Rates on municipal bonds have continued to decrease in recent weeks, reaching very low levels. This has presented a favorable market to refund the District's existing, higher interest rate, bonds. Given these historic low rates, the Board decided to proceed with planning for an advance refunding of these bonds. The resolution, which was unanimously approved, authorizes the sale of refunding bonds and the application for the state credit enhancement backing. Providing no dramatic changes in the market, the District would plan to solicit bids and have the Board award sale at the November 14, 2011 meeting.

On a motion by Iverson, seconded by Maple, the Board unanimously approved the Resolution Authorizing the Approval of the Sale of General Obligation School Building Refunding Bonds; Covenanting and Obligating the District to be Bound By and to Use the Provisions of Minnesota Statutes, Section 126C.55 to Guarantee the Payment of the Principal and Interest on the Bonds. Voting 'yes' was Fossum, Maple, Iverson, Pritchard, Quinnell, Stratmoen and Nelson. No one voted 'no.'
