- I. Call to Order. Board Chair Ellen Iverson called the Regular meeting of the Northfield Board of Education to order at 7:00 PM. Stratmoen was absent.

  - Laura Berdahl, Greenvale Park's Volunteer Coordinator/Parent Liaison, has been recognized by the Minnesota Campus Compact as a 2012 recipient of the Presidents' Community Partner Award. Laura was nominated by the ACT Center, a part of the Center for Community and Civic Engagement (CCCE), at Carleton College. The Presidents' Award gives recognition to effective community leaders in the development of campus-community partnerships. Laura has been an integral partner in the support of collaborative work between Carleton College and the Northfield School District.
  - AP Testing Results: 400 tests taken representing the highest number of tests taken. 80% of those tests were scored with 3s or above. NHS students were enrolled in 20+ AP courses.
  - Young Sculptures Tree of Knowledge piece was installed on Division Street on the Northfield Public Library property. Funding was provided by SEMAC (Southeast MN Arts Council). The project will stay in place for one year before being moved to the High School campus. Hopes are to apply for subsequent funding.
