#### Pay 2016 Preliminary Levy Certification Narrative | September 28, 2015 Matt Hillmann, Director of Administrative Services and Val Mertesdorf, Director of Finance

#### What is the levy? What does it do for the District?

We are asking for preliminary certification of the Pay 2016 property tax levy tonight. The levy is the local portion of taxes that are authorized, either by the State or by local voters, and eventually provide us with funding. Our local levy provides approximately 22% of our overall budget. Our budget supports the resources needed – human and capital – to provide quality educational programming for students in our schools. Our proposed levy will be 0.2% less than last year's levy.

#### Truth in Taxation Timeline

After we certify this proposed levy, the District will send the information to the county auditor's office by September 30th. At that point, the County begins preparing tax statements that are mailed to taxpayers in November. We will then hold our Truth in Taxation hearing during the regular School Board meeting on December 14<sup>th</sup> and ask the Board to finalize certification of the Pay 2016 levy.

#### Tax Levy and Budgeting

The State's tax year and our budget year don't quite match up. The Pay 2016 levy covers a span from January 2016 through December 2016. Property taxes are paid in May and October each year while our budget year runs from July 2016-June 2017. These levy dollars will eventually provide a portion of our funding for that budget year.

Each levy can also include budget adjustments from previous levy years – both positive and negative. These adjustments can be made for a period of up to three years.

#### Proposed Pay 2015 Property Tax Levy

This pie graph demonstrates (see PowerPoint file) the different categories that comprise our overall proposed levy.

The table (next slide) illustrates the subtotals of the levy by fund, by voter approved, and by tax base.

Overall, a decrease in Debt Service is helping to offset an increase in the General Fund. We are essentially keeping the levy flat but have more flexibility to use the dollars we are receiving.

The voter approved category shows a reduction of \$208,394.99. This is primarily due to continued savings from the 2011-2013 bond refundings (approximately \$127,000), with the rest is due to a small decrease in our operating referendum. This operating levy decrease is due to a smaller adjustment than we have seen in previous years. On our Pay 15 levy, the Department of Education stressed districts should estimate our student enrollment as close to actual as possible. We were slightly less conservative last year than usual, resulting in a more accurate revenue forecast and smaller adjustment.

The increase in the other category of \$176,489.58 is due to an increase in Equity and Local Optional Revenue.

We have also included a five year levy analysis. You'll notice a significant increase for Pay 2012, which is due to the passage of the voter-approved operating levy. The four percent reduction for Pay 2013 was an effort by the District to help taxpayers when the legislature repealed the Market Value Homestead credit. Over the past five years the District has averaged a 1.8% increase in the levy.

#### Pay 2016 Changes

There are minor changes for Pay 2016 when compared to Pay 2015. The most notable change is the addition of the Long Term Facilities Maintenance Revenue program. This program combines the old Health & Safety, Deferred Revenue and Alternative Facilities Bonding programs into one revenue source. This revenue can be used to maintain our current buildings or prevent further erosion. The state's first estimate calculation shows that Northfield Public Schools will be receiving roughly \$250,000 more than we have in previous years.

The Uniform General Education Levy that was brought back on the Pay 2015 levy was voted to be phased out. This is roughly \$80,000 that will be phased out by 2017.

We saw an 11.49% decrease in our Debt Service levy. This was primarily due to the 2006A Capital Facility Bond being paid off. This bond paid for the repair or replacement of partial roofs at the High School, Longfellow and Sibley. In addition we have a significant debt excess reduction adjustment on our Pay 16 Levy. You may recall we are required (by statute) to levy 105% of our total debt service payments. Once the District's Debt Service fund balance reaches a certain threshold the state will reduce our levy.

#### Summary

This District is proposing we levy at our max authority of \$15,548,127.87 which represents a (0.20%) decrease compared to last year.





### **Truth in Taxation Timeline**




