School Board Meeting January 10, 2005 Northfield High School Media Center

I. Call to Order.

Chairperson Kari Nelson called the meeting of the Board of Education of Independent School District 659 to order at 7:30 p.m. No one was absent.

1. Northfield Curriculum Development Process and Accomplishments.

Curriculum and Staff Development Coordinators Amy Moeller and Lisa Carlson provided the Board with an overview of the curriculum development process being used and how teaching staff is working to provide K-12 curriculum documents in each subject area. They also updated the Board on the accomplishments of the staff in the completion of this process in a number of subject areas and the aggressive timeline for the completion of this process in the remaining curriculum areas.

3. Northfield Community Resource Center Amended Lease Agreement.

1. Renewal of Workers Compensation Policy with MSBA Insurance Trust.

The Board approved the current renewal of Worker's Compensation insurance with the MSBA Insurance Trust. However, due to a significant increase in the 2005 premium, the district has been working with the Trust administrator, Berkley Risk Administration Company, scrutinizing the increase. The current reserves appear excessive and have been challenged. Administration will report back with the final outcome of the renewal including the impact of any adjustment to the reserves.

2. Equipment Lease for Snow Plow.

The Board approved a five- year lease-to-own of a Case Wheel Loader snowplow to handle the additional parking and roadways at the new Middle School. It compliments the equipment that the district currently owns and will replace a smaller Case tractor.

3. Extension of Current Beverage Agreement until June 30, 2005.

The Board agreed extending the current beverage agreement with Pepsi-Cola of Mankato for the High School six months to June 30, 2005 to coincide with the end of the school district's fiscal year. There are no changes in any of the current provisions. This agreement covers carbonated soft drinks, Gatorade and bottled water.
